

## FULL REGISTRATION TRANSFER AGREEMENT

The purpose of this agreement is to guarantee the lifelong welfare of the collie being transferred, stipulate the buyer's rights and obligations, and to maintain the reputation of the seller. IT IS UNDERSTOOD THAT THIS DOCUMENT REPRESENTS ALL CONDITIONS OF THIS AGREEMENT AND NO FURTHER WARRANTIES, EXPRESS OR IMPLIED, ARE GIVEN BY THE SELLER. All suits and legal actions to enforce this agreement shall be brought forth in Clarion County, Pennsylvania. The laws of Pennsylvania shall apply.

**Health guarantee:** The seller guarantees that this collie is apparently free from contagious or infectious disease and does not exhibit any signs of congenital or hereditary defect. If within 10 days of transfer this collie is determined by a Vet to be ill to the extent it is unfit for purchase -OR- if, within 30 days this collie is determined by a Vet to suffer from a congenital or hereditary defect to the extent it is unfit for purchase; the buyer may exercise one of the following options:

1. Return the collie to seller for a complete refund of the purchase price.
2. Return the collie to seller for a replacement collie of equal value.
3. If the problem is treatable through reasonable Veterinarian procedures, the buyer may retain this collie and receive reimbursement from the seller for fees incurred. Reimbursement shall not exceed the purchase price and shall not include the costs of the initial Veterinary examination/diagnostic fee.

In order to exercise one of the above options, the buyer must provide detailed certification of why this collie is “unfit for purchase” from a licensed Vet. At the request of the seller, the buyer shall produce the collie for examination by the seller’s Vet for a second opinion.

THIS GUARANTEE DOES NOT WARRANT THAT A VETERINARIAN HAS EXAMINED THIS DOG. THE BUYER IS REQUIRED TO HAVE THIS COLLIE EXAMINED BY A VETERINARIAN AS SOON AFTER TRANSFER AS IS FEASIBLE.

Parasites, vaccinations, injury sustained or illness contracted subsequent to the date of transfer are the responsibility of the buyer and are NOT covered by this health guarantee. Health record and health exam/eye check results are supplied to the buyer at this time.

**Bite/Testicles:** The seller guarantees that this collie will have a correct scissors bite at one year of age. In the case of a male the seller guarantees that he will have 2 descended testicles at 6 months of age. Should this collie lack the correct bite/testicles, the buyer may return it to the seller for a replacement collie of equal value, when one becomes available. This guarantee is voided once this dog is used for breeding.

**Registration:** AKC Full registration certificate/application is given with the dog at time of transfer or will be mailed to buyer upon its receipt from AKC if it is still being processed. “Trillium” shall be included in the registered name of this collie.

**Breeding:** This collie may only be bred with an AKC registered collie. Buyer agrees to take necessary precautions to protect this collie from mis-matings. Transfer of any puppy whelped/sired by this collie to a pet shop or wholesaler is strictly forbidden.

**Resale:** If at a later date the buyer is unable or unwilling to continue ownership of this collie, the seller MUST be returned to the seller with AKC documents. In such event there will be no refund of monies paid. Transfer of this collie to a pet shop or wholesaler is strictly forbidden.

**Routine Care:** Buyer agrees to maintain this collie in an adequate manner, including annual Vet exams, booster shots, food & water, housing, shade, exercise, minimal grooming, license, etc. Buyer will not allow this dog to run at large creating a public health, welfare and safety nuisance.

IF BUYER FAILS TO MEET THESE TERMS, THE SELLER MAY REPOSSESS THIS DOG WITH NO REFUND OF MONIES PAID. IF THIS DOG CAN NOT BE RECOVERED, THE BUYER WILL, ON DEMAND, MAKE A DONATION PAYABLE TO COLLIE RESCUE OF WESTERN PA, INC. EQUAL TO THE PURCHASE PRICE OF THIS DOG AS COMPENSATION.
